# PROXY FORM INFORMATION

#### 1. Your name and number

Please print your name and MRA membership number as it appears on your membership card.

## 2. The proxy process

The instructions on your proxy form will be registered by the MRASA Secretary when your proxy form is received. You can be certain that, when a poll is taken, your pre-registered vote will be automatically included.

Even though your instructions may be specified on the proxy form, your instructions are given to your proxy in good faith that he or she will vote in accordance with your wishes.

## 3. Appointment of a proxy

If you wish to appoint the Immediate Past President (IPP) as your proxy, tick the relevant box (the second box from the top). (The IPP is the person who became President at last year's AGM and whose term concludes at this year's AGM, when all positions are declared vacant.)

If the individual you wish to appoint as your proxy is other than the IPP please tick the box marked 'Designated Proxy' (the first box) and write the person's name alongside.

If you leave this section blank, or your named proxy does not attend the meeting, the IPP will be your proxy.

Your proxy must be a member of MRASA.

**4.** Voting for a person or persons for Committee positions at the MRASA AGM You may direct your proxy whom to vote for by ticking the relevant box (the last box on the form) and writing your instructions clearly in the space provided at the bottom of the form.

Alternatively, you may allow your proxy to vote according to how they deem most suitable by ticking the box marked 'at their discretion' and leaving the voting instructions section blank.

#### 5. Voting on items of business

As there are currently no specified items of business requiring a vote at the forthcoming AGM other than the election of the MRASA Committee for the following 12 months, the instructions in the second paragraph of Point 4 (above) may not apply here.

However, if items of business other than the election of office bearers do arise, you may instruct your proxy accordingly in the space provided on the bottom of the form.

#### 6. Proxy form deadline

Your proxy form must be in the Secretary's hand prior to the stipulated commencement time of the Annual General Meeting.
